INTELLECTUAL PROPERTY RIGHTS

CONFIDENTIALITY

The College and Bharat Vikas Parishad agree to maintain the confidentiality of any confidential information exchanged as part of this MOU.

DURATION

This MOU shall be valid for five years from the date of signing and may be extended by mutual written agreement.

TERMINATION

Either party may terminate this MOU with a written notice of 30 days if the terms and conditions outlined herein are not adhered to.

AMENDMENT

Any amendments to this MOU must be made in writing and agreed upon by both parties.

DISPUTE RESOLUTION

Any dispute arising out of or in connection with this MOU shall be resolved amicably by mutual consultation and negotiation.
