MEMORANDUM OF UNDERSTANDING BETWEEN MARKANDA NATIONAL COLLEGE, SHAHABAD MARKANDA DISTT. KURUKSHETRA AND HARBIR NURSERY, VILLAGE DADLU, SHAHABAD MARKANDA DISTT. KURUKSHETRA

Harbir Nursery represented herein by its Owner, Mr. Harbir Singh S/o Late Sh. Narinder Singh, address Harbir Nursery, Vill: Dadlu, Shahabad Markanda, Distt. Kurukshetra 136135, Haryana (hereinafter referred to as "Second Party").

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

OBJECTIVES OF MOU

In particular, this MoU is intended to:-

- 1. This MoU is executed with a view to establish working/professional relationship between the two for sharing physical, human & informational resources, particularly in the areas of staff development and student training on mutually agreed terms and conditions.
- 2. Markanda National College, Shahabad Markanda may offer short duration continuing education programmes for upgrading the knowledge and skills of working technical manpower of collaborating organization on mutually agreed areas and terms & conditions.
- 3. Collaborating organization will help in the training of students and faculty on mutually agreed terms & conditions.
- Collaborating organization will help on providing suitable live projects to the students as per their development needs.
- 5. Both the parties agree to use the emblem of each other on their publications.
- 6. Both the parties will build image of each other for betterment of both.
- 7. This MoU does not preclude the possibly of Markanda National College, Shahabad

- Markanda and collaborating organization entering into similar MoUs with any other organization(s) for similar objectives.
- 8. This MoU is not a legal document for approaching the Court of Law on any matter. It is only a MoU for mutual benefit of both the parties and will continue till both the parties mutually agree to help each other. However, this MoU will be reviewed after every 3 years by both the parties for making additions and deletions in any clause(s) for mutual benefit of each other.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FOR THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE-I COOPERATION

Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective cooperation's. The parties shall keep each other informed of potential opportunities and share all information that may be relevant relevant to secure. Additional opportunities for one another. The corporation between first party and second party. Will felicitate. Effective information of the. Intellectual capabilities of the second party. Providing. Significant inputs. Of the developing. Suitable teaching. Slash training systems., keeping in mind the needs of the first party.

CLAUSE-II. SCOPE OF THE MOU

Both parties believe that. Close cooperation between the two would be a major benefit to the student community. And the staff to enhance their skills and knowledge.

The second party will give valuable inputs to the first party in teaching/training methodology so that the students fit into the horticulture/agriculture scenario meaningfully. The interaction between industry and the College Centre. Will give an insight into the latest developments/requirements of the industries and academia; the second party to permit the faculty and students of the first party to visit its campus and also involved in Industrial Training programmes for the first party. The second party will actively engage to help the delivery of the training and enhance the Made in India campaign of the first party into internships/jobs. The second party will act as a mentor for overall development of the students and faculty in academia, skill enhancement, research and overall

CLAUSE-III COORDINATION

Both the parties will appoint one member of their staff to coordinate the programme on its behalf. Further the coordination committee, consisting of

- a. Principal, Markanda National College, Shahabad Markanda
- b. Owner and Staff of the second party
- c. Program Coordinator of First Party
- d. Staff of Second Party

will periodically review and identify ways to strengthen cooperation between the two parties.

CLAUSE-IV VALIDITY

The validity of the agreement is three years from the date of agreement. The MOU will take effect from the date it is signed by representatives of both the parties. It will remain valid for three years, and may be continued there after suitable review and agreement. Both parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination both the parties will have to discharge their obligations.

CLAUSE-V ARBITRATION

Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations and agreements by the parties to the MOU.
