PURPOSE OF MOU

In particular, this MOU is intended to

1. Enhance social work aptitude among the students
2. Organize various lectures/workshops/camps on Social Services
3. Collaboration to uproot societal evils through volunteer works
4. Generate internship opportunities for the students
5. Develop moral values and respect for other living beings among students
6. Motivate students to contribute for a better society.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SETFORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause 1 CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the First Party.

Clause 2 SCOPE OF THE MOU

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their morale, values, skills and knowledge.
- 2.2 The Second Party will give valuable inputs to the First Party in teaching/training methodology so that the students may benefitted meaningfully.
- 2.3 The interaction between society and the College Centre will give an insight into the latest developments/requirements of the society; the Second Party to permit the Faculty and Students of the First Party to visit its facilities and also involve in internship/training programs for the First Party. The internship/training and exposure provided to students through this collaboration/association will build confidence and prepare the students become good citizen. Both party will provide its facility and resources for smooth conduction of outreach or extension activities.
- 2.4 The Second Party will train the students of the First Party in order to bridge the gap in life skills and make them ready for society.
- 2.5 The financial liability on account of any expenses from TA/DA and remuneration and contingency etc will be met out by the respective party from their own resources.

2.6 Each party agrees that it shall not, at any time, during or after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of any program without the express consent of both parties. Any sensitive topics that are discussed will be held in the highest confidence.

Clause 3 VALIDITY


3.1 The validity of the agreement is one year from the date of agreement.

3.3 Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations and agreements by the parties to the MOU.


