






# MEMORANDUM OF UNDERSTANDING

#### **PURPOSE**

The Parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the purpose of promotion and understanding of high performance in awareness activities and organizing various programs including internships, conferences, and other awareness activities. The purpose of the MOU is to define the areas for fundamental, socio-academic aspects in which the parties desire to work together in the future for their mutual benefit to foster a collaborative frame work between National Social Organisation and Markanda National College, Shahabad Markanda in the field with a view to benefiting from each other's initiatives and working procedures and to support collaboration among the members associated with both Parties.

#### **SCOPE**

This MOU sets forth the intentions of the parties for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the Parties later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each party's contributions, deliverables.

#### The PARTIES INTEND TO:

- Strengthen the ties between Markanda National College and NSO to make collaborative efforts in the field of Social Awareness.
- Collaboration in awareness campaigns and other field of mutual interest.
- Engage students and scholars in internship programs
- Provide free of cost mutual access to facilities available for purpose of Awareness Programs.

#### Deliverables from the college

- The College will allow N.S.O to setup stalls for promotion and creating awareness among students about the initiatives of N.S.O
- 2. Motivate students to undergo various campaign and training program organized by N.S.O.
- Logo on all online and offline modes of promotion of the event jointly organized by the college and N.S.O.

### Deliverables from the National Social Organisation

- Collaborate in organizing activities related to Social Activities.
- Providing platform to our students to undergo short projects and internship programs under National Social Organisation.
- Organizing various Seminars, heath checkup and Blood donation camp and providing education to slum area children.

#### CONFIDENTIALITY

#### ARBITRATION

Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations and agreements by the parties to the MOU.

This MOU sets forth the entire understanding of the Parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings, and agreements between the Parties, whether written or oral.

#### AMENDMENTS ON MOU

Any clause or article of MOU may be modified or amended by mutual agreement of both parties. Any change and amendment to this MOU must be in writing or signed by authorized representatives of both parties.
