MEMORANDUM OF UNDERSTANDING

AUTHORIZATION:

The Service Provider is an authorized unit from Haryana State Pollution Control Board(HSPCB) and Central Pollution Control Board(CPCB) for the treatment and dismantling of E-waste and hazardous waste generated from various fields.

TERM:

This MoU shall commence on 31.12.2022 and shall continue until the termination written notice by either party.
