**CONFIDENTIALITY:** The College and the Firm agree to maintain the confidentiality of any confidential information exchanged as part of this MOU.

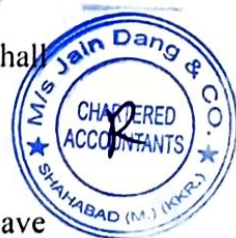
**DURATION:** This MOU shall be valid for five years from the date of signing and may be extended by mutual agreement in writing.
